Introduction

For over a century, there has been a view that the Humanities are in a crisis. Some scholars argue that the word "crisis" is inappropriate as it suggests that the Humanities are faced with extinction when all they are doing is what they have always done – reinventing themselves, staying relevant and thriving. Such scholars believe that as long as humans exist, it is inconceivable for the Humanities to be extinct. What cannot be ignored is the relentless drive in the last couple of decades towards education for economic gain, which has seen governments and corporates reduce funding for Humanities and inversely increase the funding of STEM. It might make sense, therefore, to think of the Humanities at consistent crossroads for renewal and not crisis. The real crisis, some scholars in the Humanities argue, is that those in the humanities do not articulate frequently and forcefully enough the value of the Humanities. To that end, while this conference will reflect on the "crisis" discourse, its main thrust will be how the Humanities are repositioning themselves for relevance, impact and excellence in the 21st century.

It is in this context that the South African Humanities Deans Association (SAHUDA) invites scholars, researchers, and practitioners to critically engage with the theme: "Reimagining the Humanities in the 21st Century for Impact and Excellence" at the 2025 edition of the SAHUDA biennial conference to be hosted by Walter Sisulu University. The conference aims to explore how humanities disciplines are reimagined to impact social change and justice, economic development, relevant higher education, and cultural innovation, among other key aspects. Accordingly, this call for papers will have six streams:

- Medical humanities and the future of healthcare ethics
- Business, entrepreneurship, and the humanities

4. The Future of Humanities Education

- Rethinking pedagogy in the digital age
- · Humanities and employability: new career pathways
- The role of humanities in leadership and global citizenship
- Equity, access, and inclusion in humanities education

5. Cultural Heritage, Memory, and Global Perspectives

- Preserving indigenous knowledge and cultural heritage
- Postcolonial and transnational humanities
- Migration, displacement, and historical memory
- Museums, archives, and the role of heritage in the digital era

6. Ethics, Philosophy, and the Human Condition

- Ethics in the age of AI and biotechnology
- The role of philosophy in contemporary global challenges
- Human rights, democracy, and the humanities
- The humanities and the search for meaning in a fast-changing world
